## CHAPTER II.

Be it enacted by the Legislature of the State of Minnesola:

The following amendment to article seven (7) of the constitution of the state of Minnesota, which amendment shall be termed section eight (8) of said article, is hereby proposed to the people of said state for their approval or Pertaining to rejection, which section shall read to return a provide by law, female suffrage. may, notwithstanding anything in this article, provide by law, rejection, which section shall read as follows: The legislature that any woman at the age of twenty-one years and upward,

may vote at any election held for the purpose of choosing any officers of schools, or upon any measure relating to schools, and may also provide that any such woman shall be eligible to hold any office pertaining solely to the management of schools.
